The money will be available to you to help pay for tuition, tools, equipment and living expenses, to cover forgone wages or to help support your family. Calculation based on salaries and wages paid to the apprentice.  Qualifying businesses can claim 35 per cent of eligible expenditures (45 per cent for small businesses) made during the first 48 months of an apprenticeship program. <b>Apprenticeship Job Creation Tax Credit (AJCTC)</b>	Eligibility: <b>Red Seal trades only</b>	Non-refundable tax credit equal to 10% of the eligible salaries and wages payable to eligible apprentices in respect of employment after May 1, 2006. The maximum credit an employer can claim is \$2,000 per year for each eligible apprentice. <p><b>Canada Ontario Job Grant</b></p>	<p>The Job Grant will provide direct financial support to individual employers who wish to purchase training for their employees. It will be available to small, medium and large businesses with a plan to deliver short-term training to existing and new employees, and will:</p> <p>Provide up to \$10,000 in government support per person for training costs.</p> <p>Require employers to contribute one-third of the total costs.
