1. Call to Order/Welcome

The Chair called the meeting to order at 9:45 a.m. The Program Coordinator officially welcomed the Trade Board and introduced himself. He welcomed newly appointed Trade Board member S. Cowen to the Trade Board and a round of introductions took place.

2. Approval of Agenda

The Trade Board informed the Program Coordinator that an election for a new Vice-Chair was to be added to the Agenda. **ON A MOTION MADE BY B. McIntyre, SECONDED BY G. Huffman AND CARRIED,** the agenda was approved as amended.

3. Conflict of Interest

The Program Coordinator briefed the Trade Board on the terms regarding conflict of interest as

stated in the Trade Board Orientation Manual. No conflicts of interest were declared.

4. Previous Minutes

ON A MOTION DULY MADE BY B. McIntyre, SECONDED BY P. Staite AND CARRIED the draft minutes of the Trade Board's February 12, 2015 meeting were approved as tabled.

5. Update on Trade Board Resolutions & Issues

5.1 Technical Standards and Safety Authority (TSSA)

R. Trainor updated the Trade Board on ongoing discussions with the TSSA regarding the joint regulatory responsibilities of the Elevating Devices Mechanic trade. The Trade Board voiced its concerns of the dual fees that apprentices in this trade are subject to and continues to request that the College and the TSSA work together to resolve this issue. R. Trainor advised that there are ongoing meetings scheduled with the TSSA to discuss such issues and that the two regulating authorities are looking to develop a Memorandum of Understanding.

6. Tony Dean Review

6.1 Update on Written Submissions

The Program Coordinator provided an update regarding the Dean Review. He advised that the written submissions have been posted online and showed the Trade Board where to access the submissions on the Dean Review website. The Trade Board reviewed the TSSA submission.

6.2 Meeting with Tony Dean

T. Dean met with the Trade Board and discussed his ongoing review of the College's scopes of practice and trade classification review process. Questions from the Trade Board included timing and parameters of the review.

7. Program Update

7.1 Training Standard Update

The Trade Board reviewed and discussed the draft Training Standard. The Program Coordinator informed the Trade Board of the next steps in development process of Training Standard.

7.2 Curriculum Update

The Program Coordinator advised that the Curriculum Standard for the Elevating Devices Mechanic trade is up for renewal and that the College has allocated resources for the development of this product. The Trade Board supports the development of the new Curriculum Standard. The Program Coordinator advised that the workshop will be held in the fall of 2015 and the Trade Board has been asked to nominate instructors that would be able to participate in the workshop.

7.3 Trade Fact Sheets

The Program Coordinator displayed the Earnwhileyoulearn.ca website and advised that the College will be developing new trade Fact Sheets — a one-page resource that serves as an introductory piece to the trade. The Fact Sheets will be used primarily by high school students, youth, and people looking to enter a career within the skilled trades. The Trade Board commended the College on the development of these products and in its effort to continue to fulfil its mandate of promoting the skilled trades to youth. The Trade Board suggests that the College incorporate links and information to employability factors and essential skills for the trades.
